Applicant Pre-Employment Requirements:

Completed Application Form

Pre-employment applicants must submit a completed application form as part of the application process.

Social Security Card

Pre-employment applicants must have a valid social security number and be U.S. citizens or legal permanent residents.

Resume

Pre-employment applicants must provide a copy of their most recent resume along with the application.

Proof of Education Credientials

Pre-employment applicants must provide a proof of their education credentials. A minimum of a GED certificate/high school diploma is required.

CPR & First Aid Certification

Pre-employment applicants must provide proof of current CPR & First Aid Certification.

Fingerprint Background Check from the North Carolina Department of Justice

Pre-employment applicants must provide a fingerprint background check from the North Carolina Department of Justice.

Reference Form

Pre-employment applicants must submit 2 references on the form provided by the company.

Mental Health First Aid Training

Pre-employment applicants must provide proof of the completion of the mental health first aid training.

Peer support Training and Certification

Pre-employment applicants must provide proof of the completion of the peer support training and cerfication.

Wellness Recovery Action Plan (WRAP) Training

Pre-employment applicants must provide proof of the completion of the WRAP training.

NC Intervention Training Program

Pre-employment applicants must provide proof of the completion of the NC Intervention Training Program.

Blood Borne Pathogen Certification

Pre-employment applicants must provide proof of the completion of the blood borne pathogen certification.

Motivational Interviewing Program Certificate

Pre-employment applicants must provide proof of the completion of the motiviational interview program.
